This work includes supporting all technical and project management activities and working collaboratively with project staff and consortium partners to ensure seamless implementation of project objectives. **This position is expected to have fluency in both Spanish and English** (written and spoken), operate remotely, and may require international travel.

- Organize, coordinate, and lead technical working groups, meetings, and online interactions with project partners.
- Manage and cultivate existing funder relationships; identify new grant proposal opportunities and lead proposal writing processes.
- Lead on grant reporting and other aspects of maintaining relationships with funders.
- Support and participate in project meetings with consortium partners to exchange information, provide project updates, and solve emerging challenges.
- Support and monitor key project work products from GHGMI Program Officers.

- Lead the development of capacity-building training materials on MRV topics and lead their delivery as needed, in both Spanish and English.
- Serve as a primary point of contact with government ministries and departments on data collection for GHG inventories and mitigation assessments.

- Draft technical content such as MRV guidance manuals or chapters of UNFCCC Biennial Transparency Reports, in both Spanish and English.
- Use good storytelling to excite, inform, and educate other GHG professionals on carbon management topics.
